

## **BYLAW CHANGE #1**

### **ARTICLE IV**

The board of directors for this corporation shall consist of ~~7~~ 6 District directors along with a President and Vice-President elected at large.

#### **Bylaws ARTICLE IV CHARTERED SUBDIVISIONS**

##### **SECTION A. District Unions**

1. The state union shall be subdivided into ~~seven~~ six districts, each consisting of the following counties:
  - a. District I - Bon Homme, Charles Mix, Clay/Lincoln, Douglas, Hutchinson, Turner, Union and Yankton.
  - b. District II - Aurora, Brule, Davison, Hanson, Jerauld/Bufalo, Lake, McCook, Miner, Minnehaha, Moody and Sanborn.
  - c. District III - Brookings, Clark, Codington/Hamlin, Day, Deuel/Grant, Kingsbury, Marshall and Roberts.
  - d. District IV - Bennett, ~~Custer, Fall River,~~ Gregory, Jackson, ~~Jones,~~ Lyman, Mellette, Oglala Dakota, Todd and Tripp.
  - ~~e. District V - Butte, Custer, Fall River, Haakon, Jones, Lawrence, Meade/Pennington and Stanley.~~
  - ~~f. District VI - Corson, Dewey, Harding, Perkins and Ziebach.~~
  - g. District VII - Beadle, Brown, Campbell, Edmunds, Faulk, Hand, Hughes, Hyde, McPherson, Potter, Spink, Sully and Walworth.
  - f. District VIII - Butte, Corson/Perkins, Dewey/Ziebach, Haakon, Harding, Lawrence, Meade/Pennington and Stanley.
2. Each one of these ~~seven~~ six districts shall organize itself through county delegates, electing a president, vice-president, secretary-treasurer, legislative director and three directors. There may be appointed in addition to the foregoing officers, an educational director, a cooperative director and such other officers as may be deemed necessary.

### **ARTICLE V STATE CONVENTION**

##### **SECTION B. Representation at State Convention**

1. The state union shall be composed of the members of the ~~seven~~ six districts and county unions of the South Dakota Farmers Union. Each chartered county union in good standing shall be entitled to one delegate for each ten dues-paying members or major fraction thereof.

##### **SECTION D. Nominations and Election of State Officers and Delegates to the National Farmers Union Convention.**

##### **2. Election**

- d. Board members from Districts II, IV and VIII and the president and vice president, shall be elected for a term of two years every odd numbered year. Board members from Districts I, III, V and VII, shall be elected for a term of two years every even numbered year.

### **ARTICLE VI DUTIES OF OFFICERS**

##### **SECTION D. South Dakota Farmers Union State Executive Board**

1. The state executive board shall consist of the following ~~nine~~ (9) ~~8~~ members: state president, state vice president and ~~seven~~ six ~~(6)~~ (7) directors, one (1) from each of the ~~seven~~ six districts, each member entitled to a vote.

### **ARTICLE IV CHARTERED SUBDIVISIONS**

##### **SECTION A. District Unions**
